SOLICITOR'S REPORT

- **CENTAX-Act 32 Requirements.** Solicitor Maiello related the issues with respect to the distributions that have arisen with CENTAX; a company representing approximately nine Tax Collection Districts (TCDs) throughout the State. Solicitor Maiello is attending a meeting tomorrow morning in Greentree with regard to this problem on behalf of the WCTCC and will send out a summary of the findings to all members. He also stated the WCTCC can file a claim against the bond company, and, at the previous meeting of the Operating Board, that action had been recommended.  
Linda Iezzi **MOVED** to approve Solicitor Maiello to put the bond company representing CENTAX on notice of a claim against them, and Paula Mazurek **SECONDED**. No discussion. **Motion carried.**
- **Rules and Regulations for the Tax Appeals Board.** Solicitor Maiello reported that a recommendation was made at a previous meeting with regard to Home Rule Charter entities being included with the other definitions of Political Subdivisions (PSDs). He has since made that change to the Rules and Regulations and this will be up for approval later on during this meeting.


